At this time, it was decided that because student groups are not allowed to program over the summer, the IGB would take up the request in the Fall. The IGB was also unsure about how the ambiguous use of the funds would specifically unify the University when the purpose of the Food Bank is to be private and anonymous. The decision was unanimous.
