The mission of the Interschool Governing Board (IGB) is to represent and serve the needs of Columbia University student interschool organizations whose membership and mission is interschool in nature and includes a combination of graduate and undergraduate professional schools, groups and students who do not fall under the immediate jurisdiction of other governing boards or individual school councils. IGB is dedicated to overseeing and supporting such student organizations in their efforts to bridge the gaps between various students and academic disciplines on the Columbia University campus.

The IGB Budget Committee will determine if everything has been submitted and forward a recommendation to the IGB General Body for official voting. Student Club leadership may be required to follow up with the Budget Committee or attend an IGB meeting to clarify budget details and justifications.

To be considered for recognition, clubs:

- ✓ Must complete and submit the Student Group Recognition Application
- ✓ Must have a faculty/staff **mentor** (a logistics **advisor** will be assigned to you from the Office of Student Group Advising after IGB recognition)
- ✓ Must have a designated President/Chair and Treasurer
- ✓ Must submit a written constitution, and if available, a set of bylaws

Student groups must submit the Student Group Recognition Application and all relevant materials by:

**For FALL SEMESTER recognition:**

**March 1** of the previous school year

**For SPRING SEMESTER recognition:**

**November 1** of the previous calendar year

\* No applications will be accepted over the summer.

\* Clubs with majorities from Teachers College and schools based in the Columbia University Medical Center are not eligible at this time.

### Reasons for Applying for IGB Recognition

Our purpose in applying for IGB recognition is to obtain the resources necessary to fulfill our objective of connecting students from different schools and disciplines related to Psychology at Columbia University. Specifically, we would benefit from the ability to reserve spaces to host events, fundraisers and induction ceremonies; and to obtain funding for budgetary needs such as supplies and provisions for events.

Columbia Student Engagement has informed us that the Columbia University chapter of Psi Chi Honor Society does not meet the criteria for any governing board. We are aware that our society does not currently meet the IGB criteria of having a membership consisting of at least one-half (1/2) of the students from Columbia University graduate and professional schools. However, one of the IGB clauses states that “the aforementioned criteria is suspended for clubs that do not qualify to be recognized under the jurisdiction of any other Columbia University board, council, or any other entity that can provide monetary funds and/or group space.” Since we fully meet this condition, we hope that IGB can recognize us as a qualified student group on the Columbia University campus.

### Member Benefits



1. **Valued Connections** - A strong sense of community with other members, faculty and alumni in psychology and related disciplines is created through chapter meetings, events and activities; providing optimal networking opportunities for jobs, internships, research positions and volunteer work.
2. **Educational Activities** - Membership will provide exciting, innovative opportunities for students to learn outside of the classroom through an ongoing monthly calendar of events including meetings, conferences, speaker series, panel discussions, seminars and forums.
